

TERMS AND CONDITIONS

BACK TO BUSINESS SPEND TO WIN

4. Enter by completing the Entry Form in full and submitting directly at store, at Customer Services, in any entry barrel throughout the Centre or online. You are deemed to accept these terms and conditions upon entry.
5. Entries are subject to our Privacy Policy (available for viewing on our website www.shore-city.co.nz). You are consenting to collection and storage of your entry details.
6. **Eligible entries must spend \$20 in any store in Shore City throughout the promotional period. The spend amount (\$20) must be spent in a single transaction within the promotional period.**
