Terms and Conditions

The Mystics Goal Challenge (“Promotion”) is conducted by Shore City Shopping Centre (“Shore City”) in partnership with GoSweetSpot Mystics (“Mystics”).

1. Promotion Details

- The Promotion will take place on 10 April 2026 at 1.00pm at Centre Court, Level 1, Shore City Shopping Centre.

- Each participant will have 30 seconds to score as many goals as possible.
- In the event of a tie, Shore City reserves the right to conduct a tie-breaker round or determine the winner at its discretion.
- The winner will be determined based on the highest number of successful goals scored within the 30-second period.
- All results are final, and no correspondence will be entered into.

5. Lucky Numbers Raffle

- The Lucky Numbers Raffle is limited to the first 300 participants who request a raffle ticket on the day.
- The raffle draw will take place at approximately 2.00pm at Centre Court.
- The winning number will be drawn at random and announced publicly.

- If the winner is not present, Shore City reserves the right to redraw until a winner is confirmed.
